The Gallipolis Municipal Court expended from the General Fund of the City of Gallipolis \$313,249.21 for the year 2019. The Court paid to the General Fund of the City of Gallipolis through the collection of court costs and fines \$411,065.84. This is \$97,816.63 more than expended by the City General Fund to operate the Court.

## TRAFFIC/CRIMINAL DIVISION

### **COLLECTION OF FINES**

The Court began the year with \$169,743.95 bond on hand. The Court collected \$1,053,481.61 in the Traffic/Criminal Division bringing the total ledger to \$1,223,225.56 The Court disbursed unclaimed funds in 2019 of \$20921.95 and also disbursed \$1,049,931.61 in fines/costs and bonds, leaving bond on hand for 2019 in the amount of \$152,372.00.

These include, but are not limited to, the purchase of computers and technology, special projects of the Court, probation services, house arrest, and indigent alcohol treatment and/or monitoring. ## **Felony**

The Court heard 24 preliminary hearings resulting in bind over to Common Pleas Court. 29 defendants waived their preliminary hearing and agreed to be bound over. 23 were dismissed, most of which were due to the case being taken directly to the Grand Jury of Gallia County. There are 8 outstanding felony warrants for this year.

## Criminal Misdemeanor

The Court took 335 guilty pleas on one or more original charges in misdemeanor criminal cases. The Court also heard 102 guilty pleas to reduced or amended charges. The Court had 10 bench trials on criminal cases

### OVI

The Court had 127 defendants plead guilty to OVI. There were 73 pleas of guilty to reduced charges.


### Traffic other Misdemeanor

The Court had 3488 pleas of guilty to original charges, this includes waivers of appearance on MM traffic citations. There were 353 guilty to reduced charge pleas. There were 3 trials.

The Municipal Court offers a free mediation program. This program allows individuals and small businesses the opportunity to try and resolve civil disputes through the use of a trained mediator rather than incur the expense of attorneys and court fees. There were 21 mediation

cases filed in 2019.

The Court reports monthly to the Supreme Court of Ohio regarding the number and type of cases filed, how those cases are disposed, and the timeliness of disposition. There are two reports each month titled the Administrative Judge Report and the Individual Judge report. The reports document the Court's clearance rate, which is a statistical calculation comparing the number of cases filed during the year to the number of cases terminated during the same year. The Court has an average clearance rate in excess of 100% for calendar year 2019. ## GALLIPOLIS MUNICIPAL COURT PROBATION DEPARMENT

The Gallipolis Municipal Court Probation department is comprised of three full time probation officers, including the Chief of Probation and Drug Court Coordinator. In 2019, the bulk of the expenses for these officers was paid for through a Justice Reinvestment Incentive grant. For this reason, the expenditure in 2019 from the Court's probation fund totaled only \$7004.32. The Court maintains a probation fund with an end of year balance of \$120,642.63. As of 12/31/19, the department had 950 individuals under supervision. The Court placed 178 adults on probation in 2019. There were 69 offenders placed on electronic monitoring house arrest as an alternative to jail. The average length of days served in the program was 23 days with a success rate of 83%.

In 2019 the Gallipolis Municipal Court Recovery Court served 36 participants. Of those 36, 8 graduated the program successfully. There are II participants that have carried over from 2019 into 2020. There were I6 unsuccessful discharges and I neutral discharge. The recidivism rate for graduates of the Recovery Court is currently 19%, compared to a national average of 46-60% recidivism rate for individuals sentenced to standard probation.

The security screening device recorded approximately 45,000 visitors to the Municipal Court in 2019.
