The Gallipolis Municipal Court expended from the General Fund of the City of Gallipolis \$325,102.77 for the year 2018. The Court paid to the General Fund of the City of Gallipolis through the collection of court costs and fines \$432,933.94 This is \$107,831.17 more than expended by the City General Fund to operate the Court.

### TRAFFIC/CRIMINAL DIVISION

#### **COLLECTION OF FINES**

The Court began the year with \$180,570.25 bond on hand. The Court collected \$1,088,537.95 in the Traffic/Criminal Division bring the total ledger to \$1,269,108.20 The Court disbursed unclaimed funds in 2018 of \$23,740.00 and also disbursed \$1,075,624.25 in fines and costs leaving bond on hand for 2018 in the amount of \$169,743.95

#### **Felony**

The Court heard 14 preliminary hearings resulting in bind over to Common Pleas Court. 38 defendants waived their preliminary hearing and agreed to be bound over. 23 were dismissed, most of which were due to the case being taken directly to the Grand Jury of Gallia County. There are 10 outstanding felony warrants for this year.

#### Criminal Misdemeanor

The Court took 448 guilty pleas on one or more original charges in misdemeanor criminal cases. The Court also heard 87 guilty pleas to reduced or amended charges. The Court had 25 bench trials on criminal cases. The court held one criminal jury trial.

### <u>OVI</u>

The Court had 123 defendants plead guilty to OVI. There were 117 pleas of guilty to reduced charges. The court had one bench trial on an OVI.

#### Traffic other Misdemeanor

The Court had 3722 pleas of guilty to original charges, this includes waivers of appearance on MM traffic citations. There were 278 guilty to reduced charge pleas. There were 8 trials.

The Municipal Court offers a free mediation program. This program allows individuals and small businesses the opportunity to try and resolve civil disputes through the use of a trained mediator rather than incur the expense of attorneys and court fees. There were 17 mediation cases filed in 2018.

The Court reports monthly to the Supreme Court of Ohio regarding the number and type of cases filed, how those cases are disposed, and the timeliness of disposition. There are two reports each month titled the Administrative Judge Report and the Individual Judge report. The reports document the Court's clearance rate, which is a statistical calculation comparing the number of cases filed during the year to the number of cases terminated during the same year. The Court has an average clearance rate in excess of 100% for calendar year 2018. ## GALLIPOLIS MUNICIPAL COURT PROBATION DEPARMENT

The Gallipolis Municipal Court Probation department is comprised of three full time probation officers, including the Chief of Probation and Drug Court Coordinator. In 2018, the bulk of the expenses for these officers was paid for through a Justice Reinvestment Initiative grant and a Mental Health services grant. For this reason, the expenditure in 2018 from the Court's probation fund totaled only \$4783.22. The Court maintains a probation fund with an end of year balance of \$71,631.25. As of 12/31/18, the department had 955 individuals under supervision. The Court placed 320 adults on probation in 2018. There were 99 offenders placed on electronic monitoring house arrest as an alternative to jail. The average length of days served in the program was 27 days with a success rate of 74%.
